G.S.R.36 .-In exercise of the powers conferred by section 9B, sub-section (4) of section 15 and section 15A of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the State Government hereby makes the following rules further to amend the District Mineral Foundation Trust Rules, 2016, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan District Mineral Foundation Trust (Amendment) Rules, 2018.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 1.- In sub-rule (1) of rule 1 of the District Mineral Foundation Trust Rules, 2016, hereinafter referred to as the said rules, for the existing expression "The District", the expression "the Rajasthan District" shall be substituted.

3. Amendment of rule 5.- In rule 5 of the said rules,-

(i) in table of sub-rule (1), after the existing serial number (ii) and entries thereto and before the existing serial number (iii) and entries thereto, the following new serial (ii-a) and entries thereto shall be inserted, namely:-

"(ii-a) All Members of the Parliament Trustee representing the areas of the District

(ii) in table of sub-rule (1), after the existing serial number (x) and entries thereto and before the existing serial number (xi) and entries thereto, the

(iii) and in first proviso to sub-rule (4), for the existing expression "three terms", the expression "two terms" shall be substituted.

4. Amendment of rule 9.- After the existing sub-rule (2) and before the existing sub-rule (3) of rule 9 of the said rules, the following new sub-rule (2A) shall be inserted, namely:-

"(2A) The meeting of the Governing Council shall be preside over by the Chairperson and in his absence, such meeting shall be preside over by the Vice Chairperson."

5. Amendment of rule 10.- In table of rule 10 of the said rules, after the existing serial number (viii) and entries thereto and before the existing serial number (ix) and entries thereto, the

following new serial numbers and entries thereto shall be inserted, namely:-

6. Amendment of rule 13.- In sub-rule (5) of rule 13 of the said rules, for the existing expression "any scheduled bank as decided by the trust. They shall send periodic information to Financial Advisor", the expression "interest bearing PD account. They shall send periodic information to the Additional Director (Administration), Directorate of Mines and Geology" shall be substituted.

7. Amendment of rule 14.- In rule 14 of the said rules, for the existing expression "scheduled commercial nationalized bank only", the expression "interest bearing PD account" shall be substituted.

8. Amendment of rule 15.- In rule 15 of the said rules,-

(i) in clause (II) of sub-rule (3),-

(a) in sub-clause (B), for the existing expression "five percent of the annual receipts of the Foundation subject to an upper limit fixed by the State Government may be utilized for administrative, supervisory and overhead costs of the Foundation.", the expression "three percent of the annual receipts of the Foundation subject to an upper limit fixed by the State Government may be utilized for

administrative, supervisory and overhead costs of Foundation including expenses under the provisions of rule 17, 18 and 19 of these rules." shall be substituted.;

(b) in sub-clause (C), for the existing expression "under the by the trust after obtaining prior approval of the State Government. Projects for development of common infrastructure like construction of roads, bridges etc. in excess of the limits (one crore and above)", the expression "by the trust after obtaining prior approval of the State Government. Projects for development of common infrastructure like construction of roads, bridges etc. in excess of the limits" shall be substituted;

(c) after the existing item (i) and entries thereto of the committee mentioned in sub-clause (C), the following new item (j) and entries thereto shall be added, namely:-

"(j) Additional Director (Administration), Directorate of Mines and Geology.";

(d) after the existing sub-clause (C) and before the existing sub-clause (D), following new sub-clause (CC) shall be inserted, namely:-

"(CC) Any project having an estimated cost exceeding two crore shall be sanctioned only after prior approval of the State Level Empowered Committee specified in sub-clause (C)."; and

(e) after the existing item (d) and entries thereto and before the existing item (f) and entries thereto of the committee mentioned in sub-clause (D), the following new item (e) and entries thereto shall be inserted, namely:-

"(e) Additional Director (Administration), Directorate of Mines and Geology.".

9. Amendment of rule 19.- In sub-rule (2) of rule 19 of the said rules, the existing expression "The trust may bear expenditure

up to three percentage of its accrued funds for this purpose." shall be deleted.

10. Addition of new rule 22.- After the existing rule 21 of the said rules, the following new rule 22 shall be added, namely:-

"22. Prohibition.- The State Government may prohibit any class of works or activities which may not be beneficial for fulfillment of objectives of the Trust."
