The interested and eligible bidders, upon registration on MSTC website <<http://www.mstcecommerce.com/auctionhome/mlcln/index.jsp>> will obtain login ID and Password. After successful registration, the eligible bidder can purchase the Tender Document online on payment of the tender fee of INR Rs. 50,000/- (Indian Rupees Fifty Thousand) and can participate in the e-auction process.

The GST at the rate of 18% is applicable on the purchase of tender document. The GST applicable is to be submitted by the prospective bidder itself and the copy of receipt is to be attached with the technical bid. The prospective bidder shall be solely responsible for remitting the GST as per applicable law and statutory liability in this regard will be responsibility of prospective bidder and no liability whatsoever shall be borne by the DMGR/MSTC.
