In exercise of the powers conferred by Section 11 of the Mines and Minerals (Development and Regulation) Act, 1957, its subsequent amendments and in accordance with the Mineral (Auction) Rules, 2015 as amended from time to time notified there under, the Government of Rajasthan has notified the following major mineral blocks for the purpose of grant of Composite license for Iron-ore blocks and hereby invites bids in digital format only from eligible bidders through electronic auction.
