- **G.S.R.394** .-In exercise of the powers conferred by section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act No. 67 of 1957), the State Government hereby makes the following rules further to amend the Rajasthan Minor Mineral Concession Rules, 2017, namely:-
- **1. Short title and commencement.-** (1) These rules may be called the Rajasthan Minor Mineral Concession (Amendment) Rules, 2022.
- (2) They shall come into force from the date of their publication in the Official Gazette.
- **2. Amendment of rule 2.-** After the existing clause (xliii) and before the existing clause (xliv) of sub-rule (1) of rule 2 of the Rajasthan Minor Mineral Concession Rules, 2017, hereinafter referred to as the said rules, the following new clause (xliii-a) shall be inserted, namely:—
 - "(xliii-a) "Registered dealer" means a dealer registered under these rules;"
- **3. Amendment of rule 36.-** After the existing third proviso to sub-rule (5) of rule 36 of the said rules, the following new proviso shall be added, namely:—

"Provided also that in the event of any pandemic or natural calamity, the period of existing contract may be extended by the Government for a period upto one year subject to condition that the contractor shall pay ten percent of increased amount to the existing contract amount and a rider agreement shall be executed within a period of fifteen days from the date of receipt of order of extension or before expiry of the original contract period whichever is earlier. In such cases, the difference amount of security deposit and performance security in proportion to the enhancement of contract amount shall be deposited before execution of the rider agreement. In this regard, the State Government may issue separate guidelines."

- **4. Amendment of rule 73.-** After the existing sub-rule (4) of rule 73 of the said rules, the following new sub-rule (5) shall be added, namely:—
- "(5) For generation of each e-rawanna processing fee of rupees ten shall be deposited online."
- **5. Amendment of rule 74.-** The existing sub-rule (1) of rule 74 of the said rules shall be substituted by the following, namely:—
- "(1) Notwithstanding anything contained in these rules, extraction or removal of gypsum for improvement of agriculture land, digging or extraction of brick earth used for making bricks or pottery, ordinary earth or murrum used for filling, leveling or embankment of roads or railways upto depth of three meters and removal of overburden from dumps shall not be treated as mining operations:

Provided that such operations shall be carried out under short term permit, permit or brick earth permit issued by the Mining Engineer or Assistant Mining Engineer concerned."

- **6. Insertion of new rule 81A.-** After the existing rule 81 and before the existing rule 82 of the said rules, the following new rule 81A shall be inserted, namely:—
- "81A. Registration of dealer.— (1) For the purpose of carrying of the business of buying, selling, storing, distributing or processing of minerals, a dealer shall be required to got registered with the Department.
- (2) The Director shall issue guidelines for making online application for registration of dealer and display the same on the departmental website all the time.
- (3) The application fee for registration shall be rupees two thousand and annual fee shall be rupees twenty five thousand.

Provided that the existing dealers already registered with the Department shall also require to pay annual fee.

- (4) After the deadline fixed in the guidelines issued by the Director under sub-rule (2), e-Rawanna and e-Transit Pass shall only be issued to the dealers who are registered and have deposited annual fee."
- **7. Substitution of rule 92.-** The existing rule 92 of the said rules shall be substituted by the following, namely:-
- **"92. e-Transit Pass.-** For transportation/dispatch of royalty paid mineral, e-Transit Pass shall be issued to the registered dealer on deposition of processing fee of rupees ten for each e-Transit Pass through e-payment."
- **8. Amendment of SCHEDULE II.** In Part-A of SCHEDULE II appended to the said rules,-
 - (i) in column number 4 against serial number 1, for the existing expression "170.00", the expression "160.00" shall be substituted;
 - (ii) in column number 3 and 4 against serial number 5, the following existing entries

(A) Slabs and tiles	
(i) Slabs & tiles having one dimension (width) 35 cm. and	500.00
above and other finished products:-	445.00
(ii) Tiles having one dimension (width) less than 35 cm.	320.00
(B) Blocks	205.00
(C) Irregular blocks processed by single wheel cutters whose diameter is not more than 60 cm located within the State of Rajasthan:	
Provided that such blocks are not processed in the factory premises where other wheel cutters having diameter more than 60	
cm or Gangsaw of any design are installed.	

shall be substituted by the following, namely:-

(A) Slabs and tiles	
(i) Slabs & tiles having one dimension (width) 35 cm. and	500.00
above and other finished products:-	
(ii) Tiles having one dimension (width) less than 35 cm.	445.00
(B) Blocks	320.00
(C) Irregular blocks processed by single wheel cutters whose diameter	205.00
is not more than 60 cm located within the State of Rajasthan:	
Provided that such blocks are not processed in the factory	
premises where other wheel cutters having diameter more than 60	
cm or Gangsaw of any design are installed.	

" and

- (iii) in column number 4 against serial number 6, for the existing expression "300.00", the expression "290.00" shall be substituted.
- **9. Deletion of FORM–33, FORM–34 and FORM–35.-** The existing FORM–33, FORM –34 and FORM 35 appended to the said rules shall be deleted.
