In exercise of the powers conferred by Section 11 to be read with Section 10B and Section 11 of the Mines and Minerals (Development and Regulation) Act, 1957, its subsequent amendments and in accordance with the Mineral (Auction) Rules, 2015 as amended from time to time notified there under, the Government of Rajasthan has notified the following major mineral blocks for the purpose of grant of Mining lease and Composite license & hereby invites bids in digital format only from eligible bidders through electronic auction.
