- Ambuja Cement Ltd. had submitted technical bid for the Joga-I, Joga-III, and Joga-IV blocks in District Jaisalmer, while ACC Ltd. submitted the technical bid for the Nimana-Duniya Extension block in District Kota. However, both companies have been technically disqualified from participating in the respective auction processes under Section 6 of the MMDR Act, 1957, as the total area held by them, including existing mining leases and Letters of Intent (LoIs) issued for mining leases, along with those held by their affiliates, exceeds the permissible limit of 50 square kilometers within the State.
- The initial price offer (IPO) of the blocks (except for blocks mentioned at serial no 14, 19 & 20) will be opened on the scheduled date i.e 09-06-2025.
